

If

- the investor's **urban design** was improved twice by planning administration's demand due to park's size and shape, sunlight supply of kindergartens and primary schools open spaces
- in **social housing design** secondary rooms quality is checked: position, size and shape of bike and pram stalls; comfortable washing saloons have visual connections to playgrounds
- public park and playground design considers also the play and sport interests of girls
- streets offer well lit and shaded spaces for walking, biking, sitting and play on the way
- the net and time tables of public transport consider different every day patterns,
 stops are carefully situated and designed
- in participation processes the quiet are heard and the vulnerable are addressed

....than it's gender planning

Planning- a Complex Field of Action

between market forces and common interests

- -> male white middle class bias
- -> tendency to see the city only as a technical system

Gender Planning

"to stand in different shoes"


a strategy of quality assurance:







Gender-sensitive Park Design

1997: "Foul Play with Opportunities? – Girls into Public Space!" socio- scientific survey -> specific interests of girls have to be considered

2000: strategic project within the City's Strategy Plan

since 1999: 6 model projects - 4 with active participation of girls

evaluation: usability analysis of 5 parks, design analysis of 14 parks

2006: evaluation workshop -> planning recommendations for gender-sensitive park- and playground design


Mainstreaming: Every new or redesigned park follows the principles

Definition of Target Groups

Strategic Concept for Public Space

Children and youngster up to 14 Years

Persons with reduced mobility: permanent or temporary

Persons threatened by poverty, woorking poor

Car giving persons: to < 15 Years, old persons/people in need of care

Strategy and Learnings

analysis and research -> awarness

pilot projects -> visibility and practical experience

manuals, planning recommendations, lists of criteria -> sharing of knowledge

branding and publicity - > dissemination

lead projects, pilot processes, jury's and urban development quality boards discussions

- > start of mainstreaming

most important of all: ask the right questions!

often the simple, but important ones are not posed in mainstream planning

Impact of Gender Planning in Vienna

Mobility: Pedestrian issues, quality of public spaces, accessibility and safety of public transport stations first articulated from the women's side

Subsidised and social housing: increase of quality for buildings and open spaces


Safety issues: higher subjective feeling of safety

Green Infrastructure: quantity and quality aspects

Gender sensitive park design: better facilities for girls, safety issues

Urban design: most conflictual area- green parameters count, green infrastructure as backbone, improvements of block structures and shape of parks, shading diagrams to improve urban design, localisation of kindergartens, modest reduction or better distribution of gross floor space

Common Reservations and Fears

Additional costs

not necessarily, shift of focus - prioritize measurements in a given financial frame to get more out of investments, slightly increased planning costs

Additional workload

in the beginning - higher expenditure of time for pilot projects and new procedures, diminishes with established routines

Negative or sceptical public reactions

only in the professional "bubble" - positive resonance in the population and media, higher satisfaction of users and neighbours

Obstacles and Challenges

Individual level

problems with female colleagues and women's issues, different forms of degradation and ridiculousness, active or passive resistance

-> gender trainings, top-down support: professional behaviour, acceptance of aims

Professional level

lack of methods, tools and experience

-> pilot projects, evaluations, guidelines, trainings and workshops

Structural level

Conflicting targets, market forces and common interests, lack of personal resources: service orientation for developer leads to time pressure

-> clear planning regulations, standards, urban parameters; quality assessments

Climate Crisis as New Challenge

Urban Heat Island, heavy rains -> necessity to organize a post fossil world much faster

- -> high synergetic potential of measurements with gender planning issues map overlaying Urban Heat Islands/ vulnerable groups (age, economy..)
- -> 11 high risk areas as prioritized action areas

Vienna has a decreasing number of cars/inhabitants, but a challenge with street-parking:

Concept of Garden Streets in new strategic concept Vienna Plan

Transformative Potential of Current Crisis?

- Fair Shared City principles are more important then ever: Gender planning can contribute to fight the climate crisis and accelerate climate change adaptions
- 19th Century: transformed male engineers the structure of our cities,
- 21th Century: a similar urban restructuring is needed, but this time with female politicians, experts and a high involvement of women as citizens to tackle the challenges
- Cities in Europe with female mayors show a considerable transformative energy
- Gender planners have proofed to be many years ahead of the mainstream

Transformation as communication issue

- needs a gender lens for better acceptance
- pragmatic utopias and scenarios and broad dialogues

Social sustainable, gender-sensitive and post-fossil urban development and restructuring is a chance!
